### 1. CALL TO ORDER & DETERMINATION OF A QUORUM.

Chairperson will call the meeting of the Nueces County Emergency Services District Number Four to order and let the record show that a quorum of the Board Members is present; that the meeting has been duly called, and that notice of this meeting has been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551.

2. <u>DISCUSSION AND/OR ACTION:</u> A). To approve the June 26, 2024 regular board meeting minutes.

The commissioners reviewed the June 26, 2024 regular board meeting minutes, after the review, a motion to approve the June 26, 2024 regular board meeting minutes was made by Commissioner Hermann, motion was seconded by Commissioner Grupe, motion passed 4-0.

2. <u>DISCUSSION AND/OR ACTION:</u> B). Distributions and/or prepaids June 26, 2024 to July 10, 2024.

Accountant Garza stated the fire expenditures were \$11,864.39 and the EMS expenditures were \$37,525.33 for the June 26, 2024 to July 10, 2024 period. After a review of the expenditures, a motion to approve the Fire and EMS expenditures was made by Commissioner Swetish, Motion was seconded by Commissioner Grupe, motioned passed 4-0.

2. <u>DISCUSSION AND/OR ACTION:</u> C). To approve the June 30, 2024 Financial Statements.

Accountant Garza stated that our cash position at June 30, 2024 was \$43,141,8645 compared to \$1,835,791 for the prior year, this was \$1,306,072 higher in 2024 than 2023. Revenue for the 9 month period of June 30, 2024 were \$2,131,364 and expenditures were \$692,827 for a net revenue over expenditures of \$1,438,538. This compares to the prior period in 2023 when revenue were \$1,345,855 and expenditures were \$715,023 for a net of \$630,832. Therefore we are up \$807,706 comparing 2024 to 2023. A motion to approve the June 30, 2024 financial statement was made by Commissioner Grupe, motion was seconded by Commissioner Swetish, motion passed 4-0.

Station Update

- 1. Fixed the water line at Station 2
