Accountant Garza stated the fire expenditures were \$22,379.75 and the EMS expenditures were \$37,940.69 for the August 14, 2024 to September 11, 2024 period. Discussion of website cost was made by Commissioner Jones as to why this expenditure was made when the volunteer took care of this before?? President Atwood explained the website did not belong to the District and we had to set up our own website and be owners of that website. This is a set up cost for the District and management will work the website. A question from Commissioner Hermann on the cost of the Houser expenditure. Chief Clack explained that the cost was for the existing property at the Banquete Fire station. Also discussed was the equipment purchased at John Deere. After a review of the expenditures, a motion to approve the Fire and EMS expenditures was made by Commissioner Hermann, Motion was seconded by Commissioner Grupe, motioned passed 4-0.

2. <u>DISCUSSION AND/OR ACTION:</u> D). To approve the August 31, 2024 Financial Statements.

Accountant Garza stated that our cash position at August 31, 2024 was \$3,243,894 compared to \$1,872,094 for the prior year, this was \$1,371,800 higher in 2024 than 2023. Revenue for the 11 months period of August 31, 2024 were \$2,450,667 and expenditures were \$910,096 for a net revenue over expenditures of \$1,540,570. A motion to approve the August 31, 2024 financial statement was made by Commissioner Grupe, motion was seconded by Commissioner Jones, motion passed 4-0.
